

How to Subscribe to the PGC Class Defence.

You must be a PGC Paid Member in order to subscribe to our Class Defence. If you are not yet a Member, please register as a Member on our website and select the term of your Membership. You can do so here: www.members.profitablegiving.ca/register

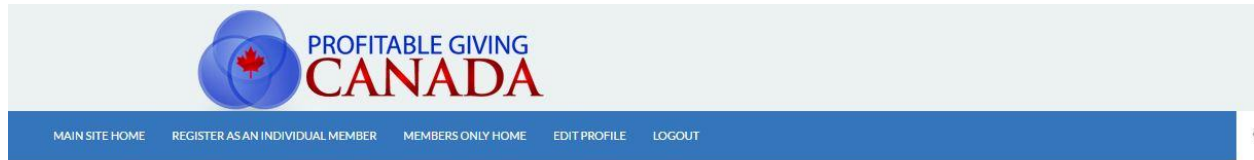

SUBSCRIBE TO PGC CLASS DEFENCE 15-1

A large group of PGC Members have applied for funds and support from PGC to defend themselves as a Class against the CRA reassessments for the 4 donation tax shelter programs listed below. The PGC Board approved the request on September 23, 2015 under certain conditions and we are now getting prepared for the CRA negotiations and litigation. If you participated in any of the four programs listed below, have settled your donation debt using the Justice Pharma program, and are a PGC Member in good standing, **we are asking you to join our Class and let us fight for your rights.** For those of you who have taken advantage of the Justice Pharma program for the purpose of settling your donation debts, Justice has committed to supporting you with an evidence package that will prove to CRA your independent debt settlement process. Justice has also committed to defending you against the collection actions from Integrated RM Inc, or any of the 4 companies below. Justice has and we believe they will continue to provide their clients with extended support. **However, Justice is not taking your case to Tax Court to defend your tax credits. You will be on your own for that action when the time comes.** However, that is what the new Class of PGC Members is planning to do for you. We have a commitment from Justice to provide our Class with ongoing support as needed. Here's a summary of details and how it will work:

1. The Class will be defined as PGC Members who have purchased settlement pharmaceuticals using the Justice Pharma program for the purpose of settling their donation debts (any year) with the 4 programs shown at the bottom of this page. We believe the 4 programs, and the CRA arguments,

This is the date of First Order with Justice Trading. We will be confirming this with Justice.
